Privacy Policy

INTRODUCTION

This document sets out the privacy policy of Hutton North LLP (an LLP incorporated in England & Wales, registered number OC454645) (referred to in this privacy policy as 'we', 'us', or 'our'). For the purposes of applicable data protection law, (in particular, the General Data Protection Regulation (EU) 2016/679 (the "GDPR") and the UK Data Protection Act 2018), your data will be controlled by Hutton North LLP.

This privacy policy applies whenever we collect your personal information (or personal data). This includes between you, the visitor to this website (whether directly as our customer or as personnel of our customer), and us, the owner and provider of this website and also where we are directed by a third party to process your personal information. This privacy policy applies to our use of any and all data collected by us or provided by you in relation to your use of the website and the provision of our services to you.

TYPES OF PERSONAL INFORMATION WE COLLECT

The personal information we collect may include the following:

- information about third parties; and
- any other information provided by you to us via this website or our online presence, or otherwise required by us or provided by you.

HOW WE COLLECT PERSONAL INFORMATION

We endeavour to ensure that information we collect is complete, accurate, accessible and not subject to unauthorised access.

We may collect personal information either directly from you, or from third parties, including where you:

- contact us through on our website;
- communicate with us via email, telephone, SMS, social applications (such as LinkedIn, Facebook or X) or otherwise;
- when you attend our events;
- · when you or your organisation offer to provide, or provides, services to us;



- interact with our website, social applications, services, content and advertising; and

We collect and use personal information for the following purposes:

 - to send you marketing and promotional messages and other information that may be of interest to you. - for our legitimate interests including:
 - to develop and carry out marketing activities and to conduct market research and analysis and develop statistics;
 - to improve and optimise our service offering and customer experience;
 - to send you administrative messages, reminders, notices, updates and other information requested by you;
 - to consider an application of employment from you; and
 - the delivery of our services.

SHARING YOUR DATA

We may share your personal information in certain circumstances, as follows:

- where there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances;
- credit-checking agencies for credit control reasons;
- · disclosures required by law or regulation; and
- service providers and other affiliated third parties to enable us to provide our services to you including
 other professional advisers such as accountants, disaster recovery service providers or auditors and/or
 overseas counsel.

SECURITY

We take reasonable steps to ensure your personal information is secure and protected from misuse or unauthorised access. Our information technology systems are password protected, and we use a range of administrative and technical measures to protect these systems. However, we cannot guarantee the security of your personal information.

YOUR RIGHTS

- You have various rights with respect to our use of your personal information:
- Access: You have the right to obtain access to your information (if we're processing it) and certain other information (similar to that provided in this privacy notice). This is so that you're aware and can check that we're using your information in accordance with data protection law.
- Be informed: You have the right to be provided with clear, transparent and easily understandable information about how we use your information and your rights. This is why we're providing you with the information in this privacy policy.
- Rectification: We aim to keep your personal data accurate, current, and complete. We encourage you to contact us using our contact form to let us know if any of your personal data is not accurate or changes, so that we can keep your personal data up-to-date.
- Objecting: You also have the right to object to processing of your personal data in certain circumstances, including processing for direct marketing.
- Restricting: You have the right to 'block' or suppress further use of your information. When processing is restricted, we can still store your information, but may not use it further.

- Complaints: If you believe that your data protection rights may have been breached, you have the right to lodge a complaint with the applicable supervisory authority. In the UK, the supervisory authority is the Information Commissioner's Office.
- Withdraw consent: If you have given your consent to anything we do with your personal information, you have the right to withdraw your consent at any time. This includes your right to withdraw consent to us using your personal information for marketing purposes.

HOW LONG WE KEEP DATA

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. We will securely destroy your personal data in accordance with applicable laws and regulations.
